To: Producers interested in selling in PCFMA's Certified Farmers' Markets

Re: Applications for 2010 Markets

Thank you for your interest in selling your products within the farmers' markets operated by the Pacific Coast Farmers' Market Association.

PCFMA operates only *certified* farmers' markets, which means that all certifiable agricultural products – fruits, nuts, vegetables, eggs, herbs, nursery stock and honey – may only be sold by the producers themselves. Buying and reselling is not allowed. PCFMA applies this principal to other items sold at the market such as hot food, pastries, breads and sauces. We encourage participation by producers of these products but typically do not allow access to the market by distributors. PCFMA also allows non-food or craft items only in certain markets and under certain conditions. If you wish to sell craft items please contact PCFMA's Market Operations Manager, Vince Scalise, at 925-825-9090 before completing the application.

To sell in one or more of PCFMA's farmers' markets in 2010 you must complete the Application to Sell and return it as soon as possible with your application fee. For 2010, the application fee for producers who did not sell in PCFMA markets last year is \$100.

Producers who have previously sold in PCFMA markets must have their completed application and application fee of \$100 turned in by February 22, 2010 in order to apply for markets where they have participated in previous seasons. After February 22, the application fee for returning producers increases to \$125 and your history of market participation will no longer be considered for 2010 market assignments.

Be sure to complete the Market Reservation Request and include it with your application.

If you have current copies of your paperwork (certificates, health permits, etc.) include them with your application. If you do not yet have current copies please send in your application as soon as possible and send the additional paperwork once it arrives.

PCFMA's stall fees for 2010 vary by season and type of producer:

	Winter Rates (Effective 1-1-10) (December thru March)	Summer Rates (April thru November)
Agricultural Producer	\$25	\$35
Non-Agricultural Producer Pre-Packaged Products	\$40 or 6% of sales, whichever is greater (sales of \$667 or more)	\$50 or 6% of sales, whichever is greater (sales of \$834 or more)
Non-Agricultural Producer Processing at the Market	\$50 or 6% of sales, whichever is greater (sales of \$834 or more)	\$60 or 6% of sales, whichever is greater (sales of \$1000 or more)

The above rates are for a single 10 foot by 10 foot stall. Rates are charged according to the amount of space used at the market – if you use a stall and a half you will be charged one-and-a-half times the appropriate rate, if you use two stalls you will be charged at twice the appropriate rate, etc.

The application requires your signature by which you attest to having read PCFMA's Rules and Regulations and by which you agree to abide by those rules. A copy of the Rules and Regulations are enclosed and they are also posted on our website at www.pcfma.com/resources.php

Please note that your general liability insurance must have minimum coverage of \$500,000, and must name Pacific Coast Farmers' Market Association as an additional insured.

Important Information For Agricultural Producers:

Application fee for all Producers is \$100.

Note: For producers who sold in PCFMA's farmers' markets in 2009, the application fee increases to \$125 after February 22, 2010.

2nd Certificate Application Fee is \$100.

Note: For producers who sold in PCFMA's farmers' markets in 2009, the 2nd certificate application fee increases to \$125 after February 22, 2010.

Both producers must be cross-referenced on both certificates.

A letter from the 2nd certificate producer is required authorizing the primary producer to sell 2nd producer's products.

2010 Certified Agricultural Producer Stall Fee (Per Market Day)

December-March - \$25.00/stall (Effective 1-1-10)

April-November - \$35.00/stall

2nd Certificate fee for Certified Agricultural Producer - \$15.00 per Market Day
